

The following Local Rules and Terms of Competition have been formulated after consultation with the Rules of Golf Committee of R&A Rules Limited. In the event of a dispute arising as to the meaning of any Rule of Golf or Ladies European Tour local rule, the Rule will be interpreted according to the English edition of the Rules of Golf or Ladies European Tour Local Rules Hard Card.

**Unless otherwise noted, the penalty for breach of a local rule is the General Penalty:
Match Play: Loss of Hole. Stroke Play: Two Strokes**

SECTION A – LOCAL RULES

The following listed Local Rules, together with any additions or amendments as published by the Ladies European Tour at each golf course, will apply until further notice to all Tournaments under the auspices of the Ladies European Tour. For the full text of the Local Rules referenced below, please refer to the Official Guide to the Rules of Golf effective from January 2023 and the Clarifications updated quarterly by the R&A, available at www.randa.org.

1. OUT OF BOUNDS (RULE 18.2)

- a) A ball is out of bounds when it is beyond any wall defining a boundary.
- b) A ball that comes to rest beyond any road defining out of bounds, is out of bounds, even though it may come to rest on another part of the course.
- c) Closed Gates attached to boundary walls and fences: Model Local Rule F-26 is in effect.
"Any closed gate attached to boundary walls and fences are part of the boundary object and relief is not allowed from such a gate under Rules 15.2 or 16.1. But an open gate is not treated as part of the boundary object and may be closed or moved to a different position".

2. PENALTY AREAS (RULE 17)

- a) **Opposite Side Same Distance Relief for Red Penalty Areas.**
The Supplementary Local Rules for each tournament will specify which (if any) red penalty areas have a same distance option on the opposite side. Model local rule B-2.1 applies only to the penalty areas that are listed.
- b) **Opposite side Relief Where Ball Last Crossed Edge of Penalty Area Where the Edge and the Boundary of the Course Coincide.**
When a player's ball last crossed the edge of the penalty area where the edge of the penalty area and a boundary of the course coincide, that edge is deemed red and opposite side relief is available under model local rule B-2.1.
- c) **Dropping Zones for Penalty Areas**
Where a dropping zone is marked for a penalty area, it is an additional option under penalty of one stroke. The dropping zone is a relief area under rule 14.3, meaning that a ball must be dropped in and come to rest in the relief area.

3. EMBEDDED BALL (RULE 16.3)

Model Local Rule F-2.2 is in effect and Rule 16.3 is modified in this way:
"Free relief is not allowed when a ball embedded in any stacked turf face above a bunker".

4. ABNORMAL COURSE CONDITIONS (RULE 16.1)

- a) **Ground Under Repair**
 - i. All areas bounded by white lines including spectator crossing points where marked.
 - ii. Seams of Cut Turf: Model Local Rule F-7 is in effect.
 - iii. Grass covered cable trenches
 - iv. French drains (stone-filled drainage ditches).
 - v. For holes remaining after removing movable obstructions in part of the general area, free relief is available for lie of ball or area of intended swing, but there is no relief interference to the stance.
- b) **Immovable Obstructions**
 - i. White lined areas and the immovable obstruction they tie into, are treated as a single abnormal course condition.
 - ii. Landscaped garden areas (and everything growing in them) that are surrounded by an immovable obstruction, are treated as a single abnormal course condition.
 - iii. Mats that are secured and all ramps covering cables (anything which is secured or fastened is not considered "readily movable" if it must be unfastened to be moved).
 - iv. Roads or paths surfaced with woodchips or mulch. Individual pieces of woodchips are loose impediments.
 - v. Non-permanent bridges erected for players or spectators, unless otherwise defined on the Supplementary Local Rules.
 - vi. The part of wires or temporary cables located outside penalty areas when they are fixing positions for those floating sponsor boards located within the penalty area and cannot be moved
- c) **Temporary Water**

Model Local Rule J-2 is in effect and modified as follows:

"When temporary water accumulates on the putting green, relief is available under Rule 16.1d or:

- i. The putting green may be squeegeed between groups.
- ii. The player may have her line of play on the putting green squeegeed.
- iii. Only when authorised by the Rules Committee, the player may have the putting green squeegeed when a ball lies adjacent to the putting green in any area of the course

d) **Restriction on Relief from Stance in Animal Hole**

Rule 16.1 is modified in this way:

"Interference does not exist if the animal hole interferes with only the player's stance".

e) Restriction on Relief from Stance for Irrigation Pipes.

Rule 16.1 is modified in this way:

"Interference does not exist if an irrigation pipe(s) interferes with the player's stance"

f) Yardage Spots or Lines

Painted lines or spots (or dots) in a part of the general area cut to fairway height or less, are to be treated as ground under repair from which relief is allowed under Rule 16.1. But interference does not exist if painted lines or spots (or dots) interfere with only the player's stance.

5. IMMOVABLE OBSTRUCTIONS CLOSE TO PUTTING GREENS

Model Local Rule F-5 is in effect but is modified as follows:

"For a ball in the general area, relief is allowed only when:

- i. both the ball and the immovable obstruction lie in an area cut to fairway height or less;*
- ii. the obstruction must be within two club-lengths of the putting green;*
- iii. the obstruction must be on the players line of play and;*
- iv. the ball must be within two club-lengths of the obstruction".*

6. GREEN READING MATERIAL RESTRICTIONS

Model Local Rule G-11 is in effect in this way: Only Committee Approved material must be used. Approved material includes:

- i. Committee approved yardage books from 2022 onwards.
- ii. Committee approved pin-position sheets
- iii. Map of the competition course no larger than an A4 sized piece of paper

Restrictions on a player's handwritten notes for green reading materials apply. This is also in effect in a Pro-am played as the official competition.

7. INTEGRAL OBJECTS

- a) Bunker liners in their intended position.
- b) Wires, cables, wrapping or other objects when closely attached to trees or other permanent objects.
- c) Artificial retaining walls and/or pilings when located within penalty areas.
- d) Artificial retaining walls and/or pilings when located on the edge of bunkers (these are part of the general area)
- e) Floating sponsor displays/signs when in penalty areas (no line-of-sight relief allowed). Wires and cables anchoring them are temporary cables (see point 9, Temporary Immovable Obstructions).

NOTE: When cables are located outside the penalty area the cables are immovable obstructions (see Point 4.b vi.)

8. PERMANENT OVERHEAD POWER LINE

Model Local Rule E-11 is in effect but only if it is known or virtually certain that a player's ball strikes a power line located in bounds and not the supporting pole; the stroke is cancelled and must be replayed (see Rule 14.6). If the player does not replay the stroke, she gets the general penalty and the stroke counts, but the player has not played from a wrong place. If the player replays the stroke but does so from a wrong place, she gets the general penalty under Rule 14.7.

9. TEMPORARY IMMOVABLE OBSTRUCTIONS (TIO)

Examples include but are not limited to: all fixed clocks, advertising boards fixed to other temporary immovable obstructions or advertising boards and hole number distance indicators that are situated around teeing areas.

Model Local Rule F-22 re Temporary Power Lines and Cables and F-23 re TIO are in effect.

- a) **Dropping Zone Policy:** In the general area, when a player's ball lies in or on a TIO or so close to the TIO that it interferes with the stance or area of intended swing and relief is required, the player may:
 - Proceed under any of the options under the TIO local rule or Rule 16.1, or;
 - If dropping zones have been marked, as an additional option, the player may drop the original ball or another ball, without penalty, in the nearest dropping zone (this is true even if the dropping zone is nearer the hole). The dropping zone is a relief area under Rule 14.3 meaning that a ball must be dropped in and come to rest in the dropping zone.
- b) **Either Side Relief:** Either side relief for line-of-sight interference only. Either side relief is available for all TIOs, unless specified on the Supplementary Local Rules for each tournament. If the player has line of sight interference and is entitled to relief, she may take relief on the other side of the TIO in accordance with e(2) of the Model Local Rule F-23. Taking relief on the other side is not allowed if the player is taking relief from physical interference only using the procedures in Rule 16.1.
- c) **Drones:** If it known or virtually certain that a player's ball hits a drone in flight and in bounds, the player must replay the stroke by playing the original ball or another ball from the spot where the last stroke is made (see Rule 14.6). If the player does not replay the stroke, she gets the general penalty and the stroke counts, but the player has not played from a wrong place. If the player replays the stroke but does so from a wrong place, she gets the general penalty under Rule 14.7.

10. MOVABLE OBSTRUCTIONS

Examples include but are not limited to: free-standing advertising boards situated away from teeing areas, drinks dispensers that are on wheels or easily lifted, all cameras and their tripods, TV microphones, free standing scoring and data masts or tripods and all crossing point indicators.

11. CLUBS AND BALLS

- a) 46-inch Club Length Limitation: Model Local Rule G-10 is in effect. This is also in effect in a Pro-Am played as the official competition. Exception: This rule will not apply to amateurs playing solely in Pro-Am competitions.
- b) Club Replacement: Model Local Rule G-9 for replacement of a club that is broken or significantly damaged is in effect.
- c) List of conforming Driver Heads: Model Local Rule G-1 is in effect.
Penalty for making a stroke with a club in breach of this local rule: Disqualification.
- d) Groove and Punch Mark Specification: Model Local Rule G-2 is in effect.
Penalty for making a stroke with a club in breach of this local rule: Disqualification.
- e) Conforming Balls List: Model Local Rule G-3 is in effect.
Penalty for making a stroke with a ball not on current list in breach of this local rule: Disqualification.
- f) The One Ball Rule: Model Local Rule G-4 is in effect. (Exception: This local rule does not apply to professionals or amateur players in any pre-tournament Pro-Am or approved one-day event, or to amateurs who partner professional players in a major Pro-Am tournament).
Penalty for making a stroke at a ball in breach of this local rule: One penalty stroke for each hole where the player is in breach.

12. PACE OF PLAY POLICY (RULE 5.6b(3))

See "Pace of Play Policy" addendum at the bottom of the Hard Card.

13. STARTING POINT (RULE 5.3a)

A player is at her starting point when she is within the roped/painted area of her starting tee, including the starter's tent. When both paint and ropes are present, paint defines the starting area.

14. STOPPING PLAY; RESUMING PLAY (RULE 5.7)

The following signals will be used to suspend and resume play:

Immediate Stop/Dangerous Situation: one prolonged note of the siren.

Normal non-dangerous stop: three consecutive short notes of the siren.

Resume Play: two consecutive short notes of the siren

When play is stopped in a dangerous situation, all practice areas are immediately closed.

15. PRACTICE (RULE 5)

- a. Before or between rounds in stroke play, Model Local Rule I-1.1 is in effect and Rule 5.2 is modified as follows:
"A player must not practice on the competition course but may practice on the designated practice areas".
Penalty for breach of Rule 5.2: See penalty statement in Rule 5.2.
- Between the play of two holes, Model Local Rule I-2 is in effect and Rule 5.5b is modified as follows:
"A player must not make any practice stroke on or near the putting green of the hole just completed or test the surface of that putting green by rubbing the putting green or rolling a ball".

16. TRANSPORTATION POLICY

Model Local Rule G-6 is in effect and modifies Rule 4.3a(1) in this way:

"During a round, a player or caddie must not ride on any form of motorized transportation except as authorized or later approved by the Rules Committee. (A player taking a stroke and distance penalty is always authorized)".

Penalty for breach of this local rule: General Penalty for each hole during which there is a breach. A breach between holes applies to the next hole.

17. SCORING IN STROKE PLAY

Model Local Rule L-1 is in effect and modifies Rule 3.3b(2) in this way:

*"If a player returns a scorecard without the hole scores being certified either by the player, the marker or both, the player gets the **General Penalty (two penalty strokes)**. The penalty applies to the last hole of the player's round".*

18. METAL FENCING

- a) If a player has interference from metal fencing, Rule 16.1 will apply. In this specific case, the player must determine the nearest point of complete relief without crossing over, through or under the fencing. A player who takes relief under this clause is not entitled to proceed under clause b) of this local rule.
- b) As an additional option, relief is allowed when all of the following are true:
 - The ball lies in the general area;
 - It lies on the outside of the fencing but within four club-lengths of it, and;
 - the fencing intervenes directly between the players' ball and the hole or the ball lies within one club-length of a spot at the same distance from the hole where such intervention would exist.

The player may take free relief by dropping the original ball or another ball in the following relief area (see Rule 14.3).

- Reference point: The nearest point of complete relief in the general area which is inside the metal fencing;
- Size of Relief Area Measured from Reference Point: one-club length but with the following limits:
- Limits on Location of relief area:
 - Must be in the general area;
 - Must not be nearer the hole than the reference point, and;
 - There must be complete relief from all interference by the metal fencing.

Exceptions:

- No relief under this local rule is available from metal fencing that is closely attached to a TIO. Such fencing is deemed to be part of the TIO.
- Single units of metal fencing are movable obstructions (Rule 15.2 applies).
- A player may not obtain relief under this local rule if (a) interference by anything other than the metal fencing makes the stroke clearly unreasonable or (b) interference by the metal fencing would occur only using a clearly unreasonable stroke or an unnecessarily abnormal stance, swing or direction of play.

SECTION B – TERMS OF COMPETITION

19. DECIDING TIES

Unless otherwise specified in the Terms of Competition of a particular Tournament, in the event of a tie for first place, there will be a hole-by-hole play-off to determine the winner.

20. RECORDING AREA, SCORECARD RETURNED

The location of recording area will be detailed in the Supplementary Local Rules for each tournament. A scorecard is returned when a player has completely left (with both feet) the recording area. Score recorders are part of "The Committee" as defined in the Rules of Golf.

21. RESULTS OF THE COMPETITION – COMPETITION CLOSED

The results of the Tournament are officially announced when the final results are validated in the scoring system by the Score Recorder and approved by the Tournament Director (or somebody on her/his behalf).

22. ANTI-DOPING

Players are required to comply with and be bound by the Ladies European Tours' Anti-Doping Policy (the Anti-Doping Policy). The current version of the Anti-Doping Policy may be viewed in the Members' area of the Ladies European Tour website.

Note: Players should be aware that, under the Anti-Doping Policy, if a player is found to have committed an Anti-Doping rule violation, she may face disqualification both from the tournament at which she was tested (or otherwise committed the violation) and from any subsequent tournament in which she participated until provisionally suspended or rendered ineligible under the Policy. Disqualification in such cases includes the loss of all results, points (including for Solheim Cup) and prize money.

23. DRIVER TESTING COMPLIANCE.

It is a condition of entry that all players must comply with the "driver testing programme" that might be organized at tournaments. Refusing to submit the driver for the test, is the equivalent of breaching the Code of Conduct, with a minimum of 300 € fine.

ADDENDUM - PACE OF PLAY POLICY

The following conditions and policies shall regulate Rule 5.6 of the Rules of Golf; *Unreasonable Delay; Prompt Pace of Play* as defined by the Rules Committee. In accordance with Rule 5.6, every player must not unreasonably delay play.

A time par sheet will be created by the Rules Committee to represent the approximate amount of time allotted for the first starting times of the day (lead groups) to finish each hole during each tournament round. The time par sheet will serve as a guideline for the Rules Committee to monitor the lead groups. The time allowed for the completion of 18 holes will be determined by the Tournament Director and will be published on the official notice board.

The maximum time allocated per shot is 40 seconds; 10 extra seconds if she is the first Player to play:

- On a par 3 hole;
- An approach shot, and;
- A chip or putt.

An additional 10% will be added for each timing session – so 40 seconds will be 44 and 50 second will be 55 – anytime the Player is Monitored or Timed.

A. Definitions

Bad Time During a round: if a Player who is being Timed exceeds the maximum time allowed for an individual stroke by up to the otherwise permitted 10% on 3 separate occasions, she will incur a "Bad Time". Two "bad times" in the same tournament will be a breach (see penalty structure below).

Monitoring/Monitored/Monitor: Unofficial timing that starts when a group is "Out of Position". If a player, to play a shot, is exceeding the given time when monitored, she will receive a monitoring penalty and will be officially timed. Monitoring is not recorded in the player's timing records. In addition, if a group is not back in position after three holes when monitored, the group will be timed from the fourth hole (see point B1.b) below).

Out of Position For first groups: Being over the time allowed for the holes completed. Following groups, will be out of position if it is more than the starting interval behind the group in front.

Timing/Timed/Time: The official timing in applying the LET Pace of Play Policy. Timings will be recorded in the players' timing records and, under the policy, after 5 timings the player will be fined.

B. Procedure When Group is Out of Position

1. In the absence of mitigating circumstances, a group (or an individual) is liable to be *Monitored* or *Timed* if the group (or she) is *Out of Position*.

- a) **Monitoring.** If a decision is taken to *Monitor* the group, each Player in the group will be subject to "unofficial" individual timing by a Rules Official.

- b) **Timing.** If a decision is taken to *Time*, the Player(s) in the group that is/are subject to “official” individual Timing by a Rules Official, will be advised.

In any case (*monitoring* or *timing*), the group will be advised that they are *Out of Position* and are being *monitored* or *timed*. *Monitoring* may happen before *Timing*, but it does not have to. Periods of *Monitoring* are not recorded in a Player’s season long record, but periods of *Timing* will count.

2. Time Extension. When being *Timed* or *Monitored*, a Player is entitled to one “Time Extension” per round. This “Time Extension” entitles a Player to a further 40 seconds over the maximum time allowable for a given stroke. The extension must be very clearly communicated to the Rules Official and can be requested at any point up until the maximum time allowable for the given stroke has expired.

3. Start of Time.

- a) The *timing* will start when a Player has had sufficient time to reach her ball, it is her turn to play and she is able to play without interference or distraction.
- b) On the putting green, *timing* will start when the Player has had a reasonable amount of time to lift, clean and replace her ball, repair damage and move loose impediments on her line of play. Time spent looking at the line from beyond the hole and/or behind the ball and aligning the ball will count as part of the time taken for the next stroke.

When *Monitored*, if any Player exceeds the maximum time allocated to play a stroke, she will be informed that she has a “monitoring penalty” and will be officially *Timed*. When *Timed*, if any Player exceeds the maximum time allocated to play a stroke, she will be informed that she has had a *Bad Time*.

Excessive shot time: A player is always liable to receive a “bad time” if she exceeds 80 seconds for any shot during play, even if she (or her group) is not being timed. Under such circumstances, the position of the Player’s group relative to the group in front (or relative to the time allowed for the number of holes completed if in the first group), will not be taken into consideration.

Timing or Monitoring will cease when a group is back in position and Players may be advised accordingly.

NOTE:

- A Player who is *Timed* will have a *Bad Time* carried forward in the tournament even if her group subsequently arrives back in position or within time.
- A Player who, during a round, records two individual stroke timings during Monitoring that exceed the limit of 40 or 50 seconds but are within the 10% allowance, will be advised by the Rules Official that she will be *Timed* officially.
- Players may be timed without being advised.
- Any Player wishing to question any timing applied to her, must do so with the Tournament Director no later than 30 minutes after the completion of her round. After this time the record will stand.

C. Pace Of Play Rules And Fines

1. Procedure When Again Out of Position During Same Round: If a group is *Out of Position* more than once during a round, the above procedure will apply on each occasion, but the group will be officially timed and not monitored again. *Bad Times* and the application of penalties in the same tournament will be carried forward until the tournament is completed. A Player will not be penalised if she has a second *Bad Time* before being advised of her earlier *Bad Time*.

Penalty for breach of Local Rule (Stroke Play):

One “Bad Time” in the tournament – Verbal Warning from an Official

Two “Bad Times” in the tournament – One Stroke Penalty

Three “Bad Times” in the tournament – Two Stroke Penalty

Four “Bad Times” in the tournament – Disqualification

Penalty for Breach of Pace of Play Policy in Match Play:

Penalty for these tournaments will be listed in the Supplementary Local Rules

2. Fines and Penalties: Please be aware that a stroke(s) penalty may only be imposed if the same Player has two or more *Bad Times* while having been *Timed* during the same tournament.

- a) A “Monitoring Penalty” will have the same status as a *Bad Time*, except it will not count towards any golfing penalty. A Player having either three (3) “Monitoring Penalties” or *Bad Times* or a combination of both, will be fined € 500 rising by € 200 for each successive “Monitoring Penalty” or *Bad Time*.
- b) In addition to the above penalties, any Player who is *Timed* on five (5) occasions during a season will be fined €300 and for each further *Timing* the Player will be fined an additional €200.
- c) Any Player who has been fined for breaches of this policy during the previous season, will, in the event of a similar breach during the following season, have the applicable fine levied at double the amount.
- d) Copies of the list containing all Players *Timed* are available from the Tournament Office – ask the Tournament Director. It is your responsibility to be aware of your own up to date position.
- e) Repeat Offenses: In addition to fines, habitually slow players may be subject to additional penalties under the Code of Ethics and Standards of Conduct, including but limited to an education programme or other requirements. If a Player receives a fine under this policy in a season and she does not receive a fine in the subsequent season, her fine structure will revert to the standard fine structure under the policy.
